1. Our Commitment to Inclusion

Our website is built using Wix.com, which provides a range of accessibility tools and features. While we actively use these features, some limitations of the Wix platform may affect full compliance with all accessibility standards.

We have taken the following actions to improve accessibility:

- Enabled Wix Accessibility Settings
- Reviewed templates for color contrast and logical content structure
- Avoided motion elements that could trigger photosensitive conditions
- Used descriptive alt text for images and headings
- Designed layouts with screen readers in mind

4. Ongoing Efforts and Audits

We are committed to continuous improvement. As we grow, we plan to:

- Conduct periodic accessibility reviews and audits
- Consult with individuals with lived experience of disability
- Incorporate accessible design practices into all new content and tools
- Review third-party integrations for compatibility with assistive technologies
